*For information about how and when to obtain your booster shot, please visit the CDC website [linked here](#). If you believe you are exempt from the vaccine requirement, please refer to the FAQ below.

GENERAL GUIDELINES FOR ALL EVENTS

- Any attendee who is not feeling well, is experiencing symptoms of COVID-19, or who has had a COVID-19 exposure within five (5) days prior to the show **MUST** stay home.
- When possible, sanitize and/or wash your hands frequently. Hand sanitizer stations will be available in all areas.
- Cover your mouth when sneezing or coughing.
- When possible, practice social distancing from other attendees.

FREQUENTLY ASKED QUESTIONS

1. **What documentation can I provide if I recently recovered from COVID-19 and cannot provide proof of a negative PCR test, as required above?**

If you cannot provide proof of a negative PCR test because you recently recovered from COVID-19, you will be required to provide the following documentation:

- (1) proof of your positive COVID-19 test result from a test taken no more than 60 days before the event, **and**
- (2) a letter from a licensed healthcare provider or a public health official stating that you have recovered and are now asymptomatic such that it is safe for you to attend the event.

2. What documentation can I provide if I have a medical or religious exemption from the vaccine?

If you are not eligible to receive the vaccine due to a medical exemption, please provide a letter from a licensed healthcare provider or a public health official certifying your medical exemption. If you are not eligible to receive the vaccine due to a religious exemption, please provide appropriate documentation from your religious organization regarding your religious belief(s) that conflict with the vaccination requirements for the event.

If eligible for an exemption, you will be required to provide the following documentation:

(1) PGA approval of a letter certifying the exemption, as set forth above (please send to pgaadmin@producersguild.org); **AND**

(2) proof of a negative COVID-19 PCR test result from a test taken within the applicable time frame for the event, as described above (must be a lab-based PCR test; at home tests are not permitted); **AND**

(3) proof of a negative COVID-19 antigen test result from a test taken within two (2) hours of the start time of the event you are attending (at home tests are OK).

3. What documentation can I provide if I'm missing some element of the full vaccination and booster requirement?

If you are missing some element of the full vaccination and booster requirement, you will either have to complete the missing element(s) of the protocols, as required above, or otherwise provide proof that you have a medical or religious exemption (in which case you will be required to provide the documentation set forth in Question 2).

4. Do I still need to abide by the PGA's COVID-19 protocols if I agree to wear a mask during the entirety of the event?

Yes, all event attendees are required to abide by the PGA's COVID-19 protocols; masking is not a substitute for compliance with the PGA's protocols.
